MEMORANDUM OF UNDERSTANDING

By signing below, the Baltimore College of Dental Surgery, University of Maryland Baltimore ("Dental School"), Wor-Wic Community College ("Wor-Wic") and Chesapeake College ("Chesapeake") (Wor-Wic and Chesapeake collectively are referred to as "the Colleges"), enter into a renewal Memorandum of Understanding ("MOU") for the purpose of continuing a cooperative agreement regarding a two-phase educational experience in Dental Hygiene ("the Program"). The Program currently provides qualified College students with an opportunity to complete a Phase I Preprofessional Curriculum provided by the Colleges designed to prepare students for the Phase II Professional Curriculum provided by the Dental School. For the benefit of students on the Eastern Shore, certain parts of the Phase II didactic curriculum are made available via distance education and a Phase II clinical affiliation training site on the Eastern Shore. Upon successful completion of Phase I and Phase II a student will be eligible to apply for the bachelor's degree in Dental Hygiene from the Dental School.

In order to effectuate the Program, the parties agree as follows:

The Phase I curriculum of the Colleges is equivalent to the prescribed courses of the Dental School's Phase I Preprofessional Curriculum for the Dental Hygiene Bachelors of Science degree. The Phase I curriculum of the Colleges is submitted to the University System of Maryland to ensure courses are equivalent with the Dental School curriculum and to obtain overall approval of the Program. Approved course equivalents are listed in ARTSYS, the Articulation System of Maryland Colleges and Universities.

The Colleges advise prospective students about careers in Dental Hygiene and provide advising about the requirements for Phase I and Phase II of the Program. Students are advised that no Phase I student is guaranteed admission to Phase II. The Dental School will keep the Colleges reasonably apprised of changes to the standards and criteria used by the Dental School Admissions Committee. The Colleges will advise Students about the standards and criteria of the Dental School.

MEMORANDUM OF UNDERSTANDING**

By signing below, the Baltimore College of Dental Surgery, University of Maryland Baltimore ("Dental School"), Wor-Wic Community College ("Wor-Wic") and Chesapeake College ("Chesapeake") (Wor-Wic and Chesapeake collectively are referred to as "the Colleges"); enter into a renewal Memorandum of Understanding ("MOU") for the purpose of continuing a cooperative agreement regarding a two-phase educational experience in Dental Hygiene ("the Program"). The Program currently provides qualified College students with an opportunity to complete a Phase I Preprofessional Curriculum provided by the Colleges designed to prepare students for the Phase II Professional Curriculum provided by the Dental School. For the benefit of students on the Eastern Shore, certain parts of the Phase II didactic curriculum are made available via distance education and a Phase II clinical affiliation training site on the Eastern Shore. Upon successful completion of Phase I and Phase II a student will be eligible to apply for the bachelor's degree in Dental Hygiene from the Dental School.

In order to effectuate the Program, the parties agree as follows:

The Phase I curriculum of the Colleges is equivalent to the prescribed courses of the Dental School's Phase I Preprofessional Curriculum for the Dental Hygiene Bachelors of Science degree. The Phase I curriculum of the Colleges is submitted to the University System of Maryland to ensure courses are equivalent with the Dental School curriculum and to obtain overall approval of the Program. Approved course equivalents are listed in ARTSYS, the Articulation System of Maryland Colleges and Universities.

The Colleges advise prospective students about careers in Dental Hygiene and provide advising about the requirements for Phase I and Phase II of the Program. Students are advised that no Phase I student is guaranteed admission to Phase II. The Dental School will keep the Colleges reasonably apprised of changes to the standards and criteria used by the Dental School Admissions Committee. The Colleges will advise Students about the standards and criteria of the Dental School.

Renewal for August , 2009

For the duration of Phase I, students enrolled in Wor-Wic or Chesapeake, will pay all tuition and fees of and to the College and be subject to the policies and procedures of the College. A student who applies to Phase II also is subject to the policies and procedures of the Dental School. A student who is accepted to, and enrolls in Phase II will be enrolled in the Dental School, will pay all tuition and fees of and to the Dental School and will be subject to the policies and procedures of the Dental School. Students who are on on-site at College facilities for distance education may also be subject to College policies and procedures applicable to guest students.

Professional liability claims involving acts and omissions of students engaged in clinical training as part of Phase II will be covered by a blanket professional liability insurance policy obtained by the Maryland State Treasurer's Office for health professional students in the State of Maryland.

Upon receipt of all approvals of the Program by the University System of Maryland, the parties may ratify this MOU, modify this MOU, or enter into a separate affiliation agreement in order to formally document the Program.

This MOU continues the Program that began in July 1, 2006 and shall be effective for three more years from the date of this renewal.

The maximum number of students who can be enrolled in Phase II of the Program is ten. The parties estimate that approximately 4 - 5 new students will enroll each year.

Any party may terminate the Program for any reason on six months advance notice to the other parties. A reasonable effort will be made to avoid unnecessarily disrupting the educational experience of any student currently enrolled in the Program.

Each party will assign one faculty member to coordinate Program direction and administration. At the time this MOU is executed, the assigned faculty are identified as:
